What is NARFE-PAC?

NARFE-PAC is NARFE's political action committee, a tool to defend and advance the earned pay and benefits of America's current and retired civil servants by supporting the campaigns of Fed-friendly congressional candidates across the country.

NARFE-PAC is a separate, segregated fund of the association, financed solely by voluntary and direct contributions from NARFE members. No membership dues or other non-dues revenue of the association fund NARFE-PAC. That's why NARFE-PAC needs the generous support of members like you.

Why is NARFE-PAC important?

NARFE-PAC expands our political influence and raises the profile of NARFE's top issues. The PAC creates additional opportunities for NARFE members to support Fed-friendly lawmakers running for Congress and enables NARFE to spread awareness of the issues facing federal workers and retirees with them.

The PAC strengthens relationships, connecting NARFE members and staff with lawmakers through one-on-one interactions at events in DC and in their local districts. These interactions raise awareness of NARFE's priorities and keep our legislative goals at the forefront of lawmakers' minds.

NARFE-PAC contributions are not deductible for federal income tax purposes.
